PREAMBLE AND FINDINGS

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF MORROW, GEORGIA TO SET AND DECLARE THE TAX MILLAGE RATE IN THE CITY OF MORROW, GEORGIA FOR CALENDAR YEAR 2015 AND SETTING FORTH CERTAIN INFORMATION REGARDING ROLLED BACK RATES; AND FOR OTHER PURPOSES.

BE IT ORDAINED by the Council of the City of Morrow, Georgia while in a regular Council Meeting on October 6, 2015 at 7:30 pm as follows:

Section I:

It is hereby ordained by the Mayor and Council of the city of Morrow, Georgia, that for calendar year 2015 the gross millage for maintenance and operation is 16.38 mils, less the rollback for Local Option Sales Tax at 6.74 mils, leaving the net millage for maintenance and operation purposes to be set at 9.64 mils. Appendix A shall be a part of this Ordinance by reference.

Section II:

All Ordinances or part of Ordinances in conflict herewith are hereby repealed and shall be of no further force or effect from the date of the enactment of this Ordinance.

Section III:

This Ordinance is hereby enacted and shall be of full force and effect from this the 6th day of October, 2015.
