*Synopsis: Judge Pro Tem Ethan Pham's current contract expires on July 24, 2019, a change in the term will be made from 1 year to 1 year and 6 months to align both the Judge and the Judge Pro Tem contract.*


Mayor Jeffrey DeTar called for a motion to adjourn the July 23, 2019 Regular Meeting.
