November 24, 2020 Regular Meeting Minutes

Mayor John J. Lampl II called the Regular Council Meeting of the Morrow City Council to order at 7:30pm on November 24, 2020. The meeting took place in the Council Chambers of the Morrow Municipal Complex located at: 1500 Morrow Rd, Morrow, and GA 30260.

Mayor John Lampl, Councilwoman Dorothy Dean and Councilman Khoa Vuong was present for the meeting in person. **Mayor Pro Tem Van Tran, and Councilwoman Renee Knight** was present via Conference Call (to ensure Governor Kemp's COVID-19 Social Distancing guidelines were being met).

Mayor Lampl asked for everyone to stand for the Pledge of Allegiance, followed by a moment of silent reflection.

The motion passed unanimously with 4 votes.
