Council discussed agenda items and the addition of a New Business Item 5 to increase the C&C bid amount for the Lake Harbin sidewalks from \$393,326 to \$457,234.50. The Mayor reminded the Council they would have to amend the agenda during the regular meeting to add that item.

2. Multi-family Moratorium update - Public Hearing and First Reading April 13

The Mayor asked staff to prepare a second moratorium to address mixed use development.

Brief discussion about the moratorium to remind people it is going to give the Mayor and Council and Planning and Zoning Board a chance to create a profile of what we want to help direct future development.

3. Annual City Council Planning Meeting – scheduled for April 24th

The Mayor suggested that the meeting start at 9 and that each presentation would likely take an hour.

4. FLOCK Camera Proposals

Major Tatroe from Morrow Police Department presented a city-wide plan for FLOCK cameras. The Mayor suggested Morrow should start with fewer cameras, pick hot spots. The Council decided that one camera needs to be placed at the dog

park, and asked Major Tatroe to create a list that prioritizes camera placement based on enforcement activity and hot spots.

5. New Business List

The Economic Developer presented the new businesses that have opened or changed ownership. He also notified Council that the basic training for the URA would take place next Monday.

Mayor Lampl adjourned the Work Session at 7:40.
