

**ORDINANCE NO. 2020 – 02**

**AN ORDINANCE TO AMEND TITLE 3 FINANCE: CHAPTER 4 – SCHEDULE OF FEES: SECTION 3-4-1 SCHEDULE OF FEES TO BE PAID TO THE CITY; TO PROVIDE FOR CODIFICATION; TO REPEAL CONFLICTING ORDINANCES; TO PROVIDE AN EFFECTIVE DATE; AND FOR OTHER PURPOSES**

**THE COUNCIL OF THE CITY OF MORROW HEREBY ORDAINS**

**WHEREAS:** City of Morrow ("City") is a municipal corporation duly organized and existing under the laws of the State of Georgia, and is authorized pursuant to Article 6 of the City Charter to levy fees delineated therein;

**WHEREAS:** City is further authorized pursuant to Section 6.17 of the City Charter to levy any other tax or fee allowed by law;

**WHEREAS:** Various portions of the City Charter, the City's Code of Ordinances, and, provisions of State law provide additional authority for the imposition collection of various fees; and

**WHEREAS:** City desires to amend the official Schedule of Fees that may be levied and collected within the City;

**WHEREAS:** At the discretion of the Mayor and City Council, they have the authority to adjust fees to cover administrative costs.

**SECTION 1. Code Section Amended.** Title 3: Chapter 4: Section 3-4-1 of the Code of Ordinances of the City of Morrow, Georgia, is hereby amended will the changes as follows:

**1. Replace**

**SECTION 2.** Codification. This ordinance shall be codified in a manner consistent with the laws of the State of Georgia.

**SECTION 3.** Severability. If any section, paragraph, sentence, clause or phrase of this Ordinance is held to be invalid or unconstitutional for any reason by a decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance, which such portions shall remain in full force and effect.


