

RESOLUTION NO. 2022-01

AN ORDINANCE TO AMEND TITLE 3 OF THE CITY OF MORROW CODE OF ORDINANCES; TO PROVIDE FOR CODIFICATION; TO REPEAL CONFLICTING ORDINANCES; TO PROVIDE AN EFFECTIVE DATE; AND FOR OTHER PURPOSES

THE COUNCIL OF THE CITY OF MORROW HEREBY ORDAINS

WHEREAS, the City of Morrow (“City”) is a municipal corporation duly organized and existing under the laws of the State of Georgia, and is authorized pursuant to Article 6 of the City Charter to levy fees delineated therein;

WHEREAS, the City is further authorized pursuant to Section 6.17 of the City Charter to levy any other tax or fee allowed by law;

WHEREAS, various portions of the City Charter, the City’s Code of Ordinances, and, provisions of State law provide additional authority for the imposition collection of various fees; and

WHEREAS, at the discretion of the Mayor and City Council, they have the authority to adjust fees to cover administrative costs.

SECTION 1. Code Section Amended. Title 3 of the Code of Ordinances of the City of Morrow, Georgia, is hereby amending the following in Chapter 4: Section 3-4-1. Schedule of Fees; Department, Sanitation; Fee Type, Commercial Sanitation Fees; Fee amounts as follows:

CS-2	Commercial Sanitation Late Fee	10% of the balance due per month
CS-3	Commercial Sanitation Reestablishment Fee	\$50 per account to reestablish service that was discontinued due to a past due balance
CS-4	Sanitation Complaints with Contractor – Missed Pick up	Once notified of a missed pick-up, if the contractor does not take corrective action within 24 hours or by Monday at 12 pm if the event falls on the weekend, each incident will result in a \$100 penalty per day imposed by the City and deducted monthly from payables owed to the Contractor. If the contractor reports that a missed pick-up has been remedied, and in fact it has not, each incident will result in an additional \$100 penalty imposed by the City.
CS-5	Sanitation Complaints with Contractor – Spills and Leaks from Sanitation Contract Hauler’s Garbage Trucks	If a spill or leak caused by either the sanitation contract hauler’s garbage truck or the process of collecting garbage, the clean-up of the spills, leaks, and stains will be the responsibility of the Contractor. A clean-up schedule for any spill or leak must be submitted to the Public Works Department within 24 hours of the spill or leak. For every day the clean-up is not completed according to the clean-up schedule, the City will impose a \$100 dollar penalty. Penalties shall be deducted by the City from payables due to Waste Pro. These penalties shall apply to both residential and commercial services.

The City of Morrow, Georgia, its Departments, and authorized employees may charge the referenced fees and costs on behalf of the City, as specified pursuant to Code of Ordinances Section 3-4-1 and the Schedule of Fees. Said fees and costs paid shall be remitted to the City of Morrow.

SECTION 2. Codification. This ordinance shall be codified in a manner consistent with the laws of the State of Georgia.

SECTION 3. Severability. If any section, paragraph, sentence, clause or phrase of this Ordinance is held to be invalid or unconstitutional for any reason by a decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance, which such portions shall remain in full force and effect.

SECTION 4. Approval of Execution. The Mayor is hereby authorized to sign all documents necessary to effectuate this Ordinance. The City Clerk is authorized to execute, attest to, and seal any document which may be necessary to effectuate this Ordinance.

SECTION 5. Repeal of Conflicting Provision. Except as otherwise provided herein, all ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

SECTION 6. Effective Date. This ordinance shall take effect immediately.
