MOTION AND VOTE: Mayor Lampl called for a motion to approve and adopt October 10, 2023, meeting minutes. Councilwoman Knight made the motion, seconded by Councilwoman Dean. **THE MOTION PASSED UNANIMOUSLY.**

2. AWARDS AND PRESENTATIONS:

3. NEW BUSINESS:

1. Approval of City Managers recommendation for the purchase of a 2023 Compact Excavator from Bobcat totaling \$85,464.00 from fund of the General Fund as budgeted in FY23 under equipment purchases for Public Works; and to authorize the mayor to execute any related documents.

MOTION AND VOTE: Mayor Lampl to approve Item 1 under New Business. **Councilwoman Knight** made the motion, seconded by **Councilman Vuong**. **THE MOTION PASSED UNANISMOULY.**

2. Approval of Morrow Fire Chief recommendation to accept a 100% grant (no match) from the Georgia Trauma Commission in the amount of \$2,235.94. The funds can be used to purchase anything related to trauma care; and to authorize the mayor to execute any related documents.

MOTION AND VOTE: Mayor Lampl called for a motion to approve Item 2 Under News Business. **Councilwoman Knight** made the motion, seconded by **Councilman Vuong**. **THE MOTION PASSED UNANIMSOULY.**

3. Approval of Morrow Fire Chief recommendation to accept a 100% grant (no match) from the Home Fire Sprinkler Coalition in the amount of \$250. Funds are to be used to purchase a TV to be mounted on the side of the fire safety trailer and will be play fire safety videos on the TV at community outreach events; and to authorize the mayor to execute any related documents.
